Volltext	<p>Integration assistance pursues the goal of preventing an impending mental disability or eliminating or mitigating the consequences of a disability. Your participation in life in the community is to be maintained or restored after a longer stay in hospital or longer isolation. You will find support in coping with daily life. This includes in particular</p> <ul style="list-style-type: none"> <li>• housing</li> <li>• finances</li> <li>• household management</li> <li>• the organization of leisure time</li> <li>• the promotion of private contacts and hobbies</li> <li>• visits to public offices (preparation and support), if not the task of a legal guardian</li> <li>• Parenting</li> </ul> <p>The time of care is usually for a longer period of time and individually designed. The costs for the services are covered by the competent institution for integration assistance if an individual need for support is determined. If necessary, income and assets are</p>

Erforderliche Unterlagen	An informal application to the competent authority suffices. This will ask you to use a form and submit further documents.
Voraussetzungen	<ul style="list-style-type: none"> <li>• the existence of an actual or imminent mental disability</li> </ul> <p>as well as</p> <ul style="list-style-type: none"> <li>• a restriction of participation.</li> </ul> <p>The individual need for support is identified in the context of a participation and overall plan procedure by the competent integration assistance institution.</p>

Verfahrensablauf	<ul style="list-style-type: none"> <li>• You shall contact the integration assistance provider responsible for you. There you can ask for advice and support or make an informal application.</li> <li>• The competent authority will ask you to fill in a form and submit further documents.</li> <li>• The Authority will carry out a participation and/or overall plan procedure to determine your individual needs for integration assistance.</li> <li>• When all documents are available, the competent authority checks on the basis of your information whether or to what extent you will receive integration assistance.</li> <li>• After examining your application, you will receive a notice of approval or rejection.</li> </ul>
Bearbeitungsdauer	
Frist	None The authority to which the application is submitted must determine within two weeks of receipt of the application whether it is responsible for the application. If the authority is not competent, it shall forward the application without delay.
