Volltext	For the renewal of ratings from the pilot license (license), depending on the license, proof of a certain number of flight hours, takeoffs and landings, as well as practice flights with flight instructor or proficiency checks by recognized examiners must be provided, as well as proof of physical and mental fitness as determined by an aeromedical expert by presenting a certificate of fitness.
Erforderliche Unterlagen	Proof of the renewal conditions for the respective authorization
Voraussetzungen	• Personal Requirements: physical and mental fitness as determined by an aero-medical expert reliability of character • Technical requirements: Proof of specified minimum number of take-offs and landings if applicable, practice flight with flight instructor If applicable, successful completion of a practical proficiency check, which usually includes a test of theoretical knowledge. Proof of knowledge of the language used in radiotelephony (usually English or German)
Kosten	Costs are incurred in accordance with the valid cost regulation of the aviation administration (LuftKostV).
Verfahrensablauf	
Bearbeitungsdauer	Usually 14 days upon submission of all necessary documents.
Frist	The renewal of permits and authorizations must be applied for before their validity expires. A permit or authorization whose validity has expired can be renewed only under difficult conditions.

Informationen	A credential may also be renewed by a recognized examiner.
Hinweise	Aviation licenses are issued with an unlimited validity. A distinction must be made between these and the ratings entered in the airman's license, which are subject to a time limit and, depending on the rating, can be extended if the respective requirements are met. The theoretical and practical knowledge as well as language skills must be maintained.
