Teaser	Would you like to use a deregistered vehicle on the road? As the new owner, you can re-register it for road use.
Volltext	<p>If you have purchased a vehicle and it is still deregistered, you must re-register it if you want to use it on the road.</p> <p>This is a re-registration to another owner if there has been a change of owner. You can apply for this in person at the registration authority responsible for you or have a representative do it for you.</p> <p>The license plate with the assigned license plate must be presented to the registration authority for stamping with a stamp sticker. The registration becomes effective when the allocated license plate has been stamped and the registration certificates have been issued.</p>

### Erforderliche Unterlagen

- Registration certificate part I (vehicle registration document)
- Registration certificate part II (vehicle registration document)
- Valid electronic insurance confirmation (eVB)
- Valid main inspection and, if applicable, safety inspection
- valid identification document, e.g. identity card or passport of the vehicle owner; if the passport is presented, a current registration certificate is also required
- Account details for a SEPA mandate to collect the vehicle tax of the vehicle owner
- If available: completed application forms

If necessary, additional documents must also be submitted:

If you wish to use a new license plate:

- if already available: new (desired) license plate reserved in advance including PIN

If you are represented by a third party:

- written power of attorney and original identification document of the holder; the authorized person himself must be able to identify himself/herself with a valid identity card or passport.

In the case of re-registration for minors:

- the written declaration of consent of the legal guardians and their original identity cards; if applicable, a certificate of sole custody ("negative certificate") in the case of single parents

- Valid electronic insurance confirmation (eVB)
- Requirements:
  - Vehicle is not currently in use
  - There is a change of keeper
  - no overdue fees and expenses from previous registration processes in excess of EUR 10.00
  - no vehicle tax debts of EUR 5.00 or more; late payment penalties, interest and late payment surcharges are also taken into account when calculating the amount
  - if represented by another person, a written power of attorney must be submitted
  - Application on site and regionally also possible online
- Responsible: local vehicle registration authority

Motor vehicle registration authorities in Mecklenburg-Vorpommern are the district councils, mayors and mayors of the independent towns and the large towns belonging to the district.

The authority with local jurisdiction is the authority of the place of residence, in the case of several residences the place of the main residence or, in the absence of such, the place of residence of the applicant or person concerned. Jurisdiction is based on the place of residence of the vehicle owner (main residence according to the identity card).

In the case of legal entities, tradespeople and self-employed persons with a fixed place of business or public authorities, the registration authority of the registered office or the location of the branch or office involved is responsible.
