| Volltext | Children should be able to continue to be cared for in the family environment, even if a parent fails due to illness or for other compelling reasons (e.B. cure, childbirth) and the remaining parent cannot adequately guarantee the care. The protection of the best interests of the child is essential for the use of the aid. Aid is not provided if another person living in the household can take over the task or other means of relief, such as .B family or neighbourly support. |
| Erforderliche Unterlagen | Supporting documentation for the parent/caregiver's emergency situation. |
| Voraussetzungen | Examination of the necessity of the assistance by the local agency of public youth welfare (youth welfare office). |
| Kosten | The costs shall be borne by the local institution of public youth assistance insofar as these are not granted by other social security institutions, such as.B. household assistance in accordance with Section 38 sGB V. |
