| Teaser                           | Would you like to work as a psychotherapist in<br>Germany? Then you need a license to practice. You can<br>also obtain a license to practice if you have a foreign<br>professional qualification. To do so, you must have<br>your professional qualification recognized.  |
| Volltext                         | The profession of psychotherapist is regulated in<br>Germany. This means that in order to work as a<br>psychotherapist in Germany without any restrictions,<br>you need a license to practice. Approbation is the state<br>license to practice the profession. This means that you<br>are not allowed to work independently as a<br>psychotherapist without a license to practice.<br>You can also obtain a license to practice in Germany<br>with a professional qualification from a so-called third<br>country. Third countries are all countries that do not<br>belong to the European Union (EU), the European<br>Economic Area (EEA) or Switzerland. In order to obtain<br>a license to practice medicine, you must have your |

|                          | In the recognition procedure, the competent authority<br>compares your professional qualification with the<br>German professional qualification and checks the<br>equivalence. The equivalence of the professional<br>qualification is an important prerequisite for the<br>granting of a license to practice medicine, and in<br>addition to the equivalence of the professional<br>qualification, you must also meet other requirements<br>for the granting of the license. Further requirements<br>are, for example, sufficient German language skills and<br>health suitability.   |
|                          | If your professional qualification comes from the EU,<br>the EEA or Switzerland, other regulations apply.<br>You can also apply for the procedure from abroad.   |
| Erforderliche Unterlagen | The responsible office will inform you which<br>documents you need to submit. Important documents<br>are generally   |
|                          | <ul> <li>Proof of identity (e.g. passport or identity card)</li> <li>Marriage certificate (if your name has changed due to marriage)</li> <li>curriculum vitae</li> <li>Proof of your professional qualifications (e.g. certificates, professional certificate)</li> <li>Proof of the content and duration of your education (e.g. diploma supplement, transcript of records)</li> <li>Proof of your relevant professional experience as a psychotherapist (e.g. references)</li> <li>Information as to whether you have already submitted an application for a license to practice in Germany</li> <li>You must provide proof: You are allowed to work in the profession in your country of training.</li> <li>You do not yet live or work in the EU, the EEA or Switzerland? Then you must provide proof: You application for an entry visa for gainful employment or personal declaration.</li> </ul> |

The certificate must not be older than 3 months at the time of application.</li> <li>Proof of your health suitability: Medical certificate. The certificate must not be older than 3 months at the time of application.</li> <li>Proof of your German language skills: Language certificate.</li> <li>For the license to practice medicine, you need general German language skills at level B2. You can also submit the required language certificate during the licensing procedure. During the licensing procedure, you must also take a specialist language test at level C2.</li> </ul> |
|                 | The responsible office will tell you which documents you need to submit as a simple copy, a certified copy or the original.   |
|                 | If your documents are not in German, you must submit<br>German translations of your documents. The<br>translations must be made by translators who are<br>publicly appointed or authorized.   |
| Voraussetzungen | <ul> <li>You have a professional qualification as a psychotherapist from a third country.</li> <li>You want to work as a psychotherapist in Germany.</li> <li>Personal suitability: You are reliable to work as a psychotherapist and have no criminal record.</li> <li>Health suitability: You are mentally and physically fit to work as a psychotherapist.</li> <li>You have German language skills at the required level. This is usually general language skills at level B2 according to the Common European Framework of Reference for Languages (CEFR) and technical language skills at level C2.</li> </ul>  |
| Kosten          | The responsible office will inform you of the costs. The costs generally depend on the time and effort required for processing.   |

|                  | Additional costs may also be incurred (e.g. for<br>translations or certifications). These costs vary from<br>case to case.  |
| Verfahrensablauf | **Application**   |
|                  | You submit an application for a license to practice as a psychotherapist to the competent authority.  |
|                  | You can hand in the application with the documents to<br>the relevant office or send it by post. Do not send any<br>originals. Sometimes you can also send the application<br>electronically. The competent body will inform you.   |
|                  | The competent authority will then check whether your<br>training corresponds to the German training and<br>whether all other requirements have been met.<br>Approval can only be granted if your training from<br>abroad is equivalent to the German training.  |
|                  | **Examination of equivalence**  |
|                  | The competent authority compares your professional<br>qualification from abroad with the German<br>professional qualification. The competent authority will<br>check whether your professional qualification is<br>equivalent. The professional qualification is equivalent<br>if there are no significant differences between your<br>foreign professional qualification and the German<br>professional qualification. |
|                  | **Possible results of the examination**   |
|                  | If your professional qualification is equivalent, your<br>foreign professional qualification will be recognized.<br>The authority can confirm the result in writing. You<br>must still meet the other requirements and provide<br>proof of your language skills. You will then be granted<br>a license to practice as a psychotherapist.  |
|                  | Are there any significant differences between your<br>professional qualification and the German professional<br>qualification? You may be able to compensate for the<br>differences through your professional experience,<br>other knowledge or skills (lifelong learning). You must  |

|                   | provide evidence of your professional experience.<br>Knowledge and skills must be certified by an authority<br>in the country in which you acquired the knowledge or<br>skills.   |
|                   | However, it is possible that the essential differences<br>cannot be compensated for by this knowledge. You will<br>then not be allowed to work as a psychotherapist in<br>Germany.  |
|                   | The competent authority will inform you of the<br>essential differences and why you cannot compensate<br>for the essential differences through your professional<br>practice. The decision of the competent authority will<br>also state the level of your training and the level<br>required in Germany. |
|                   | **Compensatory measure**  |
|                   | You can take a compensation measure to compensate for the significant differences.  |
|                   | If you have acquired your professional qualification in a third country, you can take the following compensation measure:   |
|                   | • Knowledge examination: The knowledge<br>examination is based on the final examination as a<br>psychotherapist in Germany. The knowledge<br>examination is an application-oriented examination.  |
|                   | If you pass the knowledge test and meet all other requirements, you will be licensed as a psychotherapist.  |
| Bearbeitungsdauer | 4 Monat(e)<br>The responsible office will confirm that your<br>application and documents have been received after a<br>maximum of one month. The competent office will<br>inform you if any documents are missing. If the<br>documents are complete, the procedure will take a<br>maximum of 4 months.    |

| Frist                           | There is no deadline. Sometimes documents are still<br>missing from the procedure. The responsible office will<br>then inform you by when you must submit the<br>documents. This may prolong the procedure.   |

| Hinweise                        | <ul> <li>**Temporary professional license**</li> <li>With the so-called temporary professional license, you can work for a limited period of time without a license.</li> <li>With a temporary work permit, you can work under the supervision of a person with a license to practice medicine. You may then only be allowed to carry out activities in a specific area of work. You must meet the following requirements for the professional license:</li> <li>Proof of your professional qualification</li> <li>Health suitability</li> <li>Personal aptitude</li> <li>German language skills: You must provide proof of the German language skills required to exercise the profession within the scope of the professional license.</li> </ul> |
|                                 | You can apply for a professional license from the<br>competent authority.<br>**Certificate of equivalence**<br>The equivalence assessment (recognition procedure)<br>can also take place during the licensing procedure. You<br>can apply for a separate decision on the result of the<br>examination.  |

|               | **Procedure for ethnic German repatriates**<br>As a late repatriate, you can go through the recognition<br>procedure either in accordance with the laws<br>mentioned here or in accordance with the Federal<br>Expellee Act. You can decide for yourself. The<br>responsible office will advise you on which procedure<br>is right for you.   |
| Rechtsbehelf  | You can take legal action against the decision of the<br>competent authority within a certain period of time<br>(for example, by lodging an objection). The decision will<br>then be reviewed. Details can be found in the<br>information on legal remedies at the end of your<br>decision. We recommend that you first speak to the<br>responsible office before taking legal action against the<br>decision.  |
