Basic premium including the greening payment for the proper and ecological management of agricultural land and an additional premium for the first 46 hectares as well as a further premium for young farmers for 90 hectares. Who is eligible? Agricultural enterprises, regardless of their legal form. How is support provided? Basic premium (as part of the farm payment entitlements): A payment entitlement is activated by means of the proper management of one hectare of agricultural land, including a greening payment if certain requirements are met in the context of crop diversification, the maintenance of ecological priority areas above certain area sizes and for the maintenance of permanent grassland.</p> <p>Redistribution premium: Farmers are granted an additional premium for the first 46 hectares. The redistributive payment is approximately EUR 50.00 per</p>
