| Volltext                      | Vehicles belonging to a craft business or a care service company can receive a parking permit from the responsible authority. This can, for example, entitle them to park free of charge in restricted parking bans, in residents' parking zones or in parking space management zones (parking spaces with parking meters or parking ticket machines). The exemption permit is only valid for certain individual activities of the company.<br>Please note the exact content of the exemption permit. Above all, when using the exemption permit, other persons must not be endangered or hindered. |
