Teaser	As a non-profit organization or social service, you can apply for an exemption from stopping and parking bans from the relevant road traffic authority.
Volltext	Vehicles belonging to a non-profit organization or a social service can receive a parking permit from the competent authority. This may, for example, entitle the vehicle to park free of charge in restricted no-parking zones, resident parking zones or parking management zones (parking spaces with parking meters or parking ticket machines). The exemption permit is usually only valid for certain individual activities of the non-profit organization or social service. Please note the exact content of the exemption permit. Above all, when using the exemption permit, other people must not be endangered or hindered.
Erforderliche Unterlagen	The documents to be submitted vary from authority to authority. For example, you must submit a copy of the vehicle registration certificate.
Voraussetzungen	The competent authority examines the application for a parking permit. There is no entitlement on the part of the applicant.

Kosten	• Exemption permit: EUR 10.20 to 767.00 • The amount of the fee varies depending on the number of vehicles, the period of validity of the parking permit and its area of validity.
Verfahrensablauf	You must submit an application for a special permit. How the application can be submitted varies from authority to authority. The authority will then check your application and issue the exemption if necessary.
Bearbeitungsdauer	varies between the authorities
Frist	none The period of validity of the exemption can be limited.
