Teaser	You can apply for an exemption from parking bans if you look after people in need of care as part of "family care" and are dependent on a motor vehicle that you have to park at the respective location (in the residents' parking area).
Volltext	Family care vehicles can receive a parking permit from the responsible authority. This can, for example, entitle the holder to park free of charge in restricted no-parking zones, resident parking zones or parking management zones (parking spaces with parking meters or parking ticket machines). The exemption permit is generally only valid for certain individual family care activities. Please note the exact content of the exemption permit. Above all, when using the exemption permit, other people must not be endangered or hindered.
Erforderliche Unterlagen	The documents to be submitted vary from authority to authority. For example, you must submit a copy of the vehicle registration certificate.

	a parking permit. There is no entitlement on the part of the applicant.

Verfahrensablauf	You must submit an application for a special permit. How the application can be submitted varies from authority to authority. The authority will then check your application and issue the exemption if necessary.
