Teaser	As a business or freelancer, you can apply for an exemption from stopping and parking bans from the relevant road traffic authority.
Volltext	Vehicles belonging to a business or self-employed person can receive a parking permit from the competent authority. This can, for example, entitle the holder to park free of charge in restricted no-parking zones, resident parking zones or parking management zones (parking spaces with parking meters or parking ticket machines). The exemption permit is generally only valid for certain individual activities of the business or freelancer. Please note the exact content of the exemption permit. Above all, when using the exemption permit, other persons must not be endangered or hindered.
Erforderliche Unterlagen	The documents to be submitted vary from authority to authority. For example, you must submit a copy of the business registration and a copy of the vehicle registration certificate.
Voraussetzungen	The competent authority examines the application for

	a parking permit. There is no entitlement for the applicant.
Kosten	Verwaltungsgebühr: 10,20€ - 767€ The amount of the fee varies depending on the number of vehicles, the period of validity of the parking permit and its area of validity.
Verfahrensablauf	You must submit an application for a special permit. How the application can be submitted varies from authority to authority. The authority will then check your application and issue the exemption if necessary.
