Teaser	If you are a student, you must take out health insurance - either through family insurance or independently.
Volltext	<p>Students must prove that they have health insurance when they enrol for their studies. Even if they do not live in Germany.</p> <p>Health insurance is also compulsory for periods of work experience completed during the course of study.</p> <p>As a rule, students can be insured through their parents in a statutory health insurance fund free of charge, provided that one parent is a member of a statutory health insurance fund. However, family insurance is only possible up to the age of 25.</p> <p>For students who are married or in a registered civil partnership, family insurance is possible via the spouse or civil partner if they are insured in the statutory health insurance scheme.</p> <p>If health insurance through the parents or partner is not possible, statutory health insurance companies or private health insurance companies offer reduced premiums.</p>
