Erforderliche Unterlagen	• Application for health assistance • Identity card or passport (or other documents that can identify the person beyond doubt). The competent social welfare institution will provide information on the documents required in individual cases.
Voraussetzungen	Health assistance is provided to persons, • who do not have statutory health insurance or do not have sufficient private health insurance, • the provision of services via the health insurance fund is out of the question • and who cannot reasonably be expected to raise the
