| Volltext                         | Anyone who is admitted to hospitals, nursing homes or<br>other facilities that serve to care for people in need of<br>care or disabled people or to provide home education<br>does not need to register as long as they are registered<br>for another home in Germany. Anyone who is not<br>registered for a home in Germany must register within<br>two weeks as soon as their stay exceeds three months.<br>For persons who cannot fulfill their registration<br>obligation in person (e.g. due to infirmity), the<br>managers of the facilities must notify the registration<br>authority responsible for the location of the facility of<br>the admission within two weeks. The persons<br>concerned must be informed of this.<br>For persons for whom a guardian has been appointed<br>who can determine the place of residence, the duty of<br>notification is incumbent on the guardian.<br>If an authority determines that it is necessary in an<br>individual case to avert a significant and present<br>danger, to prosecute criminal offences or to clarify the<br>fate of missing persons and accident victims, hospitals,<br>homes and similar institutions must provide the<br>competent authority with information from their |
