| Volltext                 | If you have been assessed as having a degree of<br>disability of at least 50, you can apply for a severely<br>disabled person's pass.  |
|                          | This will be issued for a limited or unlimited period of time, depending on the chances of improvement in your state of health.  |
|                          | If you are a severely disabled person from a non-EU<br>country whose residence permit is temporary, the ID<br>card can only be issued for as long as the residence<br>permit is valid.   |
|                          | With the severely disabled person's ID card, you can<br>prove your status as a severely disabled person as well<br>as claim certain rights and - depending on the type of<br>entry in the card - compensation for disadvantages.   |
|                          | Compensations for disadvantages are, for example   |

|                          | <ul> <li>aG - exceptional walking disability</li> <li>H - helpless within the meaning of the Income Tax<br/>Act</li> <li>BI - blind</li> <li>GI - deaf</li> <li>RF - Reduction of the broadcasting fee</li> <li>B - Authorization to take an accompanying person<br/>with you</li> <li>G - Significant impairment of mobility in road traffic</li> <li>TBI - Deaf-blind</li> </ul> |
|                          | The basic color of the severely disabled person's pass<br>is green. If one of the following signs has been<br>determined: "G", "aG", "H", "BI" or "GI", the card is<br>printed in orange. The ID card with the orange imprint<br>allows free transportation on public transport. A valid<br>token is also required for this.   |
|                          | In the event of expiry, loss or change of other<br>important data, you must apply for a new severely<br>disabled person's ID card.   |

| Voraussetzungen          | <ul> <li>You have a notice of assessment of a disability of at<br/>least degree 50.</li> <li>If you do not have a German passport and come<br/>from a non-EU country, you need a valid residence<br/>permit.</li> </ul>  |

|                                 | If you apply to the competent authority for a disability<br>certificate, you will automatically be issued with a<br>severely disabled person's pass if you have a degree of<br>disability of at least 50, provided you already have a<br>passport photo.   |
|                                 | If this is not the case,   |
|                                 | <ul> <li>you already have an assessment notice or a corresponding administrative or court decision with a degree of disability of at least 50</li> <li>or if your existing severely disabled person's ID card is lost, damaged or expires,</li> </ul>  |
|                                 | you can apply to the competent authority for a (new) severely disabled person's ID card.   |
|                                 | You must send a photo/passport photo of yourself to<br>the relevant office for the card to be issued. The<br>responsible office will check the requirements for<br>issuing the severely disabled person's ID card.   |
|                                 | If the requirements are met, it will issue a (new) severely disabled person's ID card and send it to you.  |
