Teaser	If you have successfully completed your training in Germany and are looking for a job that matches your qualifications, you can apply for a residence permit.
Volltext	If you have successfully completed school-based or company-based training, you may be granted a residence permit to look for a job. The residence permit will be issued for a maximum of 12 months directly following your previous training. This makes it possible for you to find a job appropriate to your qualifications. The aim of the search can also be self-employment. This residence permit allows you to work without restriction.
Erforderliche Unterlagen	• Valid national passport • Proof of secure means of subsistence (e.g. training contract and payslips, bank statements, declaration of commitment by a third party) • Proof of health insurance • Proof of qualification (diploma, certificate or certificate from the training company/chamber confirming successful completion of vocational training) • 1 current biometric photo Please ask your local immigration office whether you

Voraussetzungen	You have successfully completed qualified vocational training in Germany and have a valid residence permit for the purpose of vocational training. Further general requirements for obtaining a residence permit are • a secure livelihood, • a clarified identity, • possession of a valid national passport.
Kosten	Fixed costs: fee EUR 98.00
Verfahrensablauf	You can only apply for a residence permit in person at the foreigners authority responsible for your place of residence. • You must submit the required documents in the original and pay the application fee. • The Foreigners' Registration Office will check whether the requirements for issuing the permit have been met. • If all requirements are met, the immigration authority will take your biometric data (photo, fingerprints) and order the electronic residence permit (eAT) from Bundesdruckerei GmbH. • As soon as the eAT is ready, it will be issued to you by the Foreigners' Registration Office.
Bearbeitungsdauer	The processing time may vary in the local immigration authorities (about 5 to 6 weeks).
Frist	Application before the current residence permit expires. It is recommended that you apply 4 to 6 weeks before your current residence permit expires. Application deadline 4 weeks

	• The purpose of the residence permit is to seek employment or to take up self-employment (gainful employment) that corresponds to the qualification acquired • directly following the training • valid for a maximum of 12 months • entitles the holder to gainful employment • Responsible: local foreigners authority
