Teaser	If the electoral roll for the European elections contains incorrect information, you can have this corrected.
Volltext	<p>If the electoral roll for the European elections contains incorrect information or is incomplete, you can have this corrected. This is only possible from the 20th day before the election (= start of the inspection period) following an objection or ex officio.</p> <p>The objection is only possible until the 16th day before the election (= end of the inspection period). It must be made in writing or recorded at the municipality of residence. The municipality decides on the objection by the 10th day before the election. An appeal against the decision may be lodged within two days of notification.</p> <p>The municipality may correct the electoral roll at any time if it is obviously incorrect or incomplete.</p> <p>The electoral roll is completed no later than the day before the election.</p>
Erforderliche Unterlagen	conclusive documents proving the need to correct the electoral roll or, in the absence of an entry, proof of eligibility to vote
Voraussetzungen	<ul style="list-style-type: none"> • If the electoral roll proves to be incorrect, the electoral roll is corrected. • If proof of eligibility to vote can be provided despite

	the absence of an entry, the electoral roll will be supplemented accordingly.

Verfahrensablauf	<p>Please have the electoral roll for the European elections corrected as follows:</p> <ul style="list-style-type: none"> • After inspecting the electoral roll, you discover an error in the electoral roll or you are not entered although you are entitled to vote. • You lodge an objection and provide suitable evidence to substantiate the facts. • The authority corrects the electoral roll or sends a rejection notice. If you are subsequently registered, you will receive a voter's notification.

Kurztext	<ul style="list-style-type: none"> • Register of voters for the European elections Correction <ul style="list-style-type: none"> • From the 20th day before the election - start of the period for inspection - the electoral roll can only be corrected upon objection or ex officio • Objections are only possible until the 16th day before the election (= end of the inspection period) • Objections must be made in writing or for the record • Decision of the municipality on objection no later than 10 days before the election • possibility of appeal within two days of notification • Obvious errors that are not the subject of an objection can also be corrected by the municipality ex officio
