Teaser	If, as a recognized body, you wish to carry out external inspections of waste pre-treatment plants within the framework of the Commercial Waste Ordinance, you must be a notified body.

You must submit an application to the competent authority for notification. As a notified body, you may carry out external inspections. Equivalent certificates issued abroad are recognized.

Sachverhalt

Experts who are authorized to monitor specialist waste management companies in accordance with the Ordinance on Specialist Waste Management Companies are also suitable for carrying out external inspections.

The notification can be provided with ancillary provisions.

The external inspection serves to verify the plant operator's own inspection and the data and facts collected by him (dual control principle). The prerequisite for acting as an external inspector is his recognition and notification. External inspections can then be carried out in waste pre-treatment plants within the framework of the Commercial Waste Ordinance (GewAbfV). For recognition - which entails notification - you must submit an application to the competent authority. The competent authority in Mecklenburg-Vorpommern is the State Office for the Environment, Nature Conservation and Geology. The notification is published for the entire federal territory in the official gazette of the federal state in which you submit the application for notification. You will be notified if you have the necessary expertise, independence, reliability and technical equipment. As a notified body, you may carry out third-party inspections throughout Germany. Certificates issued abroad will be recognized if they are equivalent in accordance with Section 11 (5) GewAbfV.

Erforderliche Unterlagen

- Identity card or
- Passport with confirmation of registration
- Written informal application, including extract from the commercial register/trade register
- Declaration of exemption from any liability for the activities of the third-party inspector vis-à-vis the country in which he is active
- Description of the control and monitoring methods used.

Voraussetzungen

The bodies to be notified for the external inspection must demonstrate the reliability, independence and expertise required for their activities.
