Volltext	<p>If you wish to put a cremation facility into operation, you must notify the competent authority in advance.</p> <p>Cremation facilities are all technical facilities used for the cremation of human corpses. A facility for the cremation of human corpses is also referred to as a crematorium.</p>
Erforderliche Unterlagen	Completed notification of the commissioning of a cremation facility
Voraussetzungen	You are the operator of a technical facility used for the cremation of human corpses, i.e. a cremation facility.
Kosten	There are no costs.
Verfahrensablauf	<ul style="list-style-type: none"> • You must notify the authority responsible for you of the planned operation of your cremation facility at least one month before commissioning. <ul style="list-style-type: none"> • They will check your notification. • If you have any queries, the competent authority will contact you.
