Teaser	Every dog owner is obliged to register his dog in his municipality of residence. The dog tax results from the registration.
Volltext	Every person who wants to keep a dog is obliged to register his dog in his municipality of residence. The dog tax results from the registration. The cities and municipalities decide whether they levy a tax and how they structure it. They make these regulations in their dog tax statutes. The individual municipality determines the tax rates and payment modalities for its municipal area in the statutes. Regulations on exemptions from the tax obligation or on the granting of reductions can also be found in the statutes of the respective municipality. Please note that more differentiated and supplementary regulations apply to the keeping of so-called dangerous dogs. You must submit a separate application for permission to keep a dangerous dog to your responsible regulatory authority.
