Teaser	<p>You must have the areas on which you are entitled to hunt entered in the hunting license. The entries must be corrected in the event of changes.</p> <p>Anyone wishing to hunt must be in possession of a valid hunting license. Any changes required during the term of the hunting license, such as entries, corrections and deletions of information in the hunting license, are carried out by the competent lower hunting authorities.</p>
Volltext	<p>If there have been changes to the area on which you are entitled to hunt after the hunting license has been issued, you must have these entered in your hunting license.</p> <p>The entry must be made by the authority responsible for your place of residence.</p> <p>Any changes required during the term of the hunting license, such as entries, corrections and deletions of information in the hunting license, are carried out by the competent lower hunting authorities. Entries concern, for example, the hunting lease or paid hunting permits. Corrections to the details on the hunting license include a change of name, change of address, hunting area, qualified person, etc.</p>
