Volltext	If you have applied for a building permit and would like to change individual sections of the building before the building permit is granted, you will need a partial building permit for this construction work. 	components or building sections you would like to change before the building permit is issued. The partial building permit for the modification of an installation is subject to a fee.
Erforderliche Unterlagen	• Application (via online service or in text form) If not yet submitted with the building application: • Extract from the official real estate map • site plan • Construction drawings • Building description Please contact your local building supervisory authority to find out which documents you need to submit for your specific building project.
Voraussetzungen	You receive a partial building permit: • if the underlying building application is complete with regard to the modification measures applied for for the partial building permit, • the described modification project complies with the public law regulations to be examined in the building inspection procedure.
Kosten	• Fee range: EUR 60.00 to EUR 1,680 • The fee for the individual partial building permit, insofar as it exceeds EUR 180.00, can be offset against the fee for the building permit, taking into account a lower review effort in the building permit procedure. • The cost calculation takes into account the expected costs of the construction work and the work involved in checking the parts of the building application relevant to the partial building permit.
Verfahrensablauf	You can apply for a partial building permit for the modification of an installation using the online procedure or in text form.

	Submit the application, stating which building application your application for partial building permission relates to and which construction measures it covers. Attach the required building documents. Submit the application documents to the responsible lower building supervisory authority. The lower building supervisory authority will review your application and involve the municipality and those bodies whose involvement or consultation is required for the decision on the partial building permit or without whose opinion the approvability of the application cannot be assessed. You will then receive the decision on your application. The partial building permit is subject to a fee. You will receive a notification of fees. If necessary, the lower building supervisory authority will ask you to pay a fee in advance after you have submitted your application.
Bearbeitungsdauer	
Frist	• In the regular partial building permit procedure, there is no application deadline and no approval deadline. • The partial building permit expires if work on the modification project has not begun within three years of it being granted or if work has been interrupted for more than one year. The application can be extended by up to one year within the period of validity. • If a partial building permit has been granted, the lower building supervisory authority must be notified of the start of construction at least one week before the start of construction work.
