Teaser	If you have a valid preliminary building permit for your building project, you can apply for an extension of up to one year at a time.
Volltext	If you have a valid preliminary building permit for your building project, you can apply for an extension of the preliminary building permit. The responsible lower building supervisory authority can extend the preliminary building permit by a maximum of one year in each case if the legal requirements have not changed in the meantime and the application has been received by the lower building supervisory authority before the deadline expires. The extension must be applied for before the deadline expires. The extension of the preliminary building permit is subject to a fee.

Kosten	• Fee range: EUR 60.00 to EUR 1,610 • The cost calculation takes into account the expected costs of the construction work and the work involved in checking the legal requirements of the preliminary building permit. • Up to half of the fee can be offset against the building permit fee, taking into account a lower inspection effort in the building permit procedure.
Verfahrensablauf	You can apply for an extension of the preliminary building permit online or in text form. Indicate in the application which preliminary building permit your application for extension relates to. Submit the application to the responsible lower building supervisory authority. The lower building supervisory authority will review your application and involve the municipality and those bodies whose involvement or consultation is required for the decision on the preliminary building application or without whose opinion the application cannot be assessed. You will then receive an extension of the preliminary building permit. The extension of the preliminary building permit is subject to a fee. You will receive a notification of fees. If necessary, the lower building supervisory authority will ask you to make an advance fee payment after the application has been submitted.
