All that is required is a written declaration to the Youth Welfare Office or the use of the corresponding online service. The guardianship ends automatically if the legal requirements are no longer met. This is the case, for example, if:</p> <ul style="list-style-type: none"> <li>• both parents have assumed joint custody,</li> <li>• the child has reached the age of majority</li> <li>• the single parent and the child move abroad (residence abroad),</li> <li>• the guardianship has fulfilled its purpose, for example paternity has been established.</li> </ul> |
