Teaser	You were born in Germany as a child of stateless parents? Then you are entitled to naturalization under certain conditions.
Volltext	With naturalization you receive German citizenship. This means that you become an equal citizen of the Federal Republic of Germany with all rights and obligations.
	 Among other things, you can exercise your right to vote in the federal states and for the German Bundestag, enjoy freedom of movement within the European Union as a citizen of the Union, and can also travel outside Europe to many countries without a visa.
	If you have been stateless since birth in Germany, you are entitled to acquire German citizenship through naturalization under certain conditions.
	Stateless persons are persons whom no state regards as nationals on the basis of its law.
	For this you must
	 have been born in the Federal Republic of Germany as a stateless person, have resided legally and permanently in Germany for

	at least 5 years, and • have filed the application before reaching the age of 21.
	The claim is excluded if you have been legally sentenced to a custodial or juvenile sentence of more than 5 years.
	If you are being investigated on suspicion of a criminal offense, the naturalization procedure remains suspended until the conclusion of the proceedings.
	The naturalization becomes effective by delivery of the naturalization certificate. The competent authority is the citizenship authority of your place of residence.
Erforderliche Unterlagen	 valid travel document for stateless persons valid residence permit birth certificate for persons under 16 years of age: Proof of legal representation in case of joint parental care of the parents only declaration of consent of the other parent with custody rights
Voraussetzungen	 You must apply for naturalization before your 21st birthday. You must at least 16 years old or be legally represented. You have been stateless since birth. You were born in Germany. You have been legally and permanently residing in Germany for at least 5 years. You have not been sentenced to a custodial or juvenile sentence of more than 5 years. You are not being investigated on suspicion of a criminal offense. If this is the case, the naturalization procedure remains suspended until the criminal proceedings have been concluded.

	 mail with the required documents. The competent office will review your application and decide whether you meet the requirements for naturalization. If you meet the requirements, you will finally receive a naturalization certificate. With this certificate you acquire German citizenship.

	 Action before the competent administrative court Naturalization: granting of German citizenship to stateless persons since birth. stateless persons are persons whom no state regards as nationals on the basis of its law those who have been stateless since birth in Germany are entitled to naturalization under certain conditions They must have resided legally and permanently in Germany for at least 5 years and apply for naturalization before their 21st birthday with the naturalization you receive German citizenship and are an equal citizen of the Federal Republic of Germany with all rights and obligations Your naturalization becomes effective with the delivery of the naturalization certificate. responsible: Citizenship authority of the respective place of residence
