Teaser	If you want to give up the eel fishery, you must deregister with the upper fishery authority.
Volltext	If you wish to give up eel fishing, this must be reported immediately to the upper fisheries authority (deregistration from eel fishing).The notification must include information on the name, address and coastal and/or inland fishing. After deregistration from eel fishing, you will be deleted from the fishery register as a registered person by the upper fishery authority.
