Teaser	If you want to catch eels for profit, you must register as a person with the competent authority.
Volltext	If you are a person who wishes to catch eels for profit, you must first register with the competent authority. The competent authority registers the persons who catch eels for profit under a registration number in the fishery register.

Verfahrensablauf	• They register eel fishing with the competent authority before starting their activity. • They indicate whether they fish in coastal or inland waters and delimit the fish area. • The notification is informal and the registration takes place after you have submitted the formal application to the competent authority. • You will then receive a registration number.
