Volltext	If you have lost your hunting license, you can apply for a replacement from the authority responsible for your place of residence.
Erforderliche Unterlagen	• identity card • current photograph
Voraussetzungen	• Hunting license already issued • Loss of the hunting license
Kosten	Verwaltungsgebühr: 30€ Issuing duplicates of the hunter's or falconer's examination certificate or hunting licenses
Verfahrensablauf	You can submit the application in writing or, if available, online. If you submit the application in writing, complete it and submit it by post or in person to the competent authority. The application and the evidence to be provided will be checked for completeness and correctness. If all requirements are met, you will receive a replacement hunting license.
Bearbeitungsdauer	Processing usually takes a maximum of 2 weeks. There is no statutory processing period.
