Volltext	<p>As a foreign graduate of a German university, you can apply for a residence permit to look for a job after completing your studies.</p> <p>The job you are looking for must be one for which you are qualified. The desired employment can also be self-employment.</p> <p>This residence permit can be issued for up to 18 months. The residence permit is only for the one-off purpose of looking for work and cannot be extended beyond this maximum period.</p> <p>During the job search, any gainful employment is</p>

Verfahrensablauf

- Find out whether your foreigners authority allows you to apply online or has a special application form.

- If the application can only be submitted in person, make an appointment at the immigration office. If you apply online, the immigration office will contact you after receiving your application to arrange an appointment.

- During the appointment, your identity and documents will be checked (please bring your documents to the appointment, in the original if possible).

- If your application is approved, your fingerprints will be taken to produce a new electronic residence permit (eAT card). The Foreigners' Registration Office will commission the Bundesdruckerei to produce the eAT card. After completion, you will receive information and can collect the residence permit from the relevant office. The eAT card must always be collected in person.

- If your application is rejected, you will receive a notice of rejection.

Bearbeitungsdauer

The production of the electronic residence permit by Bundesdruckerei takes about 4 to 6 weeks.

Frist

The application should be received by the Aliens' Registration Office at least 8 weeks before your valid residence permit expires. Period of validity (for a fixed period): maximum 18 months The residence permit is issued for a maximum of 18 months. It is not possible to extend the residence permit beyond this maximum
