Volltext	If your name or your main place of residence has changed after you have been issued a youth hunting license, you must have your hunting license changed. The change must be made by the authority responsible for your place of residence.

Kosten	There are no official fees.
Verfahrensablauf	You can submit the application in writing or, if available, online. If you submit the application in writing, complete it and submit it by post or in person to the competent authority.

	The application and the evidence to be provided will be checked for completeness and correctness. If all conditions are met, the change will be registered.
Bearbeitungsdauer	As a rule, processing is carried out immediately at the authority.
Frist	The hunting authority must be notified immediately of any changes.
