Teaser	If your youth hunting license has been withdrawn by the issuing authority, you can reapply for it after the specified retention period has expired.
Volltext	If you wish to hunt in Germany but are not yet 18 years old, you can only be issued a youth hunting license in your name. If your youth hunting license has been withdrawn, you can reapply for it at the authority responsible for your place of residence after the specified retention period has expired.
Erforderliche Unterlagen	• current photograph, if applicable • Proof of statutory hunting liability insurance • Consent of the person with custody
Voraussetzungen	• at least 16 and not yet 18 years old at the time of issue

Verfahrensablauf	You can submit the application in writing or, if available, online. If you submit the application in writing, complete it and submit it by post or in person to the competent authority. The application and the evidence to be provided will be checked for completeness and correctness. If you meet all the requirements, you will be issued a youth hunting license.
Bearbeitungsdauer	4 to 6 weeks
Frist	The youth hunting license is valid for a maximum of two consecutive hunting years. The hunting year begins on 01.04. and ends on 31.03.

Hinweise	The youth hunting license only entitles the holder to hunt in the company of a person with parental authority or a supervisor appointed in writing by the person with parental authority; the accompanying person must be experienced in hunting. The youth hunting license does not entitle the holder to participate in group hunts.
