Teaser	If you have information about irregularities in an offer or an event of a permitted game of chance, you can submit it anonymously.
Volltext	<p>If you disagree with a gambling provider about the outcome of your gambling transaction or the service you have received from them, you should first and foremost report these irregularities directly to the gambling provider.</p> <p>If you do not receive any feedback or are dissatisfied with the outcome, you can submit a report online.</p> <p>Your report of irregularities could, for example, relate to the following:</p> <ul style="list-style-type: none"> • whether you have won • the amount of deposits/payments • the way in which your payments were managed • General Terms and Conditions (GTC) • bonus offers • ID verification • Closure of your account • IT problems • Customer service problems <p>Relevant are reports of irregularities in gambling, for</p>

Verfahrensablauf	<p>You can submit a report online or in writing and remain completely anonymous if you wish.</p> <p>If you wish to submit your report online:</p> <ul style="list-style-type: none"> • Briefly and concisely describe your report on irregularities in permitted gambling in the whistleblowing system. • After sending your report, you will receive a reference number from the system which you can use to send additional information to the competent authority online or by post. • The whistleblower system offers you the option of setting up an anonymous mailbox. In this mailbox, the whistleblowing report and any additions are stored and the competent authority can send you feedback. • Please note: The online service is currently under development and will be made available to you at a later date. <ul style="list-style-type: none"> • If you wish to remain completely anonymous as a whistleblower, you must ensure that your details or file uploads do not allow any conclusions to be drawn about your person. • The whistleblower system is not suitable for filing police reports. • The Joint Gambling Authority of the federal states is then responsible. • The Ministry of the Interior, Building and Digitalization of Mecklenburg-Vorpommern is responsible for the formal review and approval (accompanying specialist authority in the implementing state). • The Saxony-Anhalt State Administration Office, Department 208 Transitional Tasks under Gambling
