Volltext	If there are any changes to the area on which you are entitled to hunt after you have been issued a youth hunting license, you must have these entered in your hunting license.

Voraussetzungen	• Youth hunting license already issued • Change of hunting area, if applicable
Kosten	There are no official fees.
Verfahrensablauf	You can submit the application in writing or, if available, online. If you submit the application in writing, complete it and submit it by post or in person to the competent authority. The application and the evidence to be provided will be checked for completeness and correctness. If all conditions are met, the change will be registered.
