Volltext	<p>If you wish to employ a pregnant or breastfeeding woman between 8 p.m. and 10 p.m., you must obtain permission to do so.</p> <p>The authority responsible for occupational health and safety may refuse or temporarily prohibit you from employing the pregnant or breastfeeding woman during this period in order to ensure the protection of the health of the woman or her child.</p> <p>If the supervisory authority does not refuse or provisionally prohibit employment, you may employ the woman between 8 pm and 10 pm.</p>

Voraussetzungen

- You can only submit the application if you are an employer.
 - The pregnant or breastfeeding woman must expressly declare her willingness to do so
 - A medical certificate must not speak against working until 10 p.m.
 - There is no irresponsible risk to the pregnant woman from working alone.
 - There is no irresponsible risk to the child from working alone.
 - The documented assessment of the working conditions proves that there are no other irresponsible hazards.

Kosten

The fees are charged on a time and material basis. Please enquire at the supervisory authority responsible for your federal state about the processing fees incurred.

The exact costs will be determined following approval.

Verfahrensablauf

You can apply in writing for permission to employ a pregnant or breastfeeding woman between 8 pm and 10 pm.

You can apply for approval in writing:

- Describe your request informally or use an application form if one is available.
- Send your application to the local authority responsible for occupational health and safety, including the necessary documents and evidence.
- If the documents or information required for processing are incomplete, you will be contacted immediately by the processing department.
- The local authority responsible for occupational health and safety will check the documents.
- Your application is considered approved if you do not receive a rejection within 6 weeks.
- If the requirements for approval are not met, you will receive a rejection.
- The authority responsible for occupational health and safety can also issue you with a provisional rejection.
- In the event of a rejection, you will receive a notice

of rejection.

You can apply for a permit to employ a pregnant or breastfeeding woman between 8 pm and 10 pm.

You can apply for the permit:

- Describe your request informally or use an application form if one is available.
- Send your application to the local authority responsible for occupational health and safety, including the necessary documents and evidence.
- The local authority responsible for occupational health and safety will check the documents.
- If the documents or information required for processing are incomplete, you will be contacted immediately by the processing department.
- Your application is considered approved if you do not receive a rejection within 6 weeks.
- You can request a certificate confirming the fictitious approval.
- If the requirements for approval are not met, you will receive a rejection.
- The authority responsible for occupational health and safety can also issue you with a provisional rejection.
- In the event of a rejection, you will receive a notice of rejection.

Bearbeitungsdauer

The processing time is between one day and six weeks.

Frist

The application must be submitted before the pregnant or breastfeeding woman is employed between 8 p.m. and 10 p.m.
