- Operators of certain medium-sized combustion plants, gas turbine and internal combustion engine plants must continuously measure, record and evaluate their pollutant emissions using suitable measuring equipment. As a rule, the measurement must be carried out by an accredited measuring institute or an expert
- Reason for measurement: Commissioning of the system or Emission-relevant change to the system
- Deadline for measurement: Within 4 months of commissioning or an emission-relevant change
- Responsible: competent immission control authority
