Erforderliche Unterlagen	• Publicly notarized application to the commercial register • Depending on the legal form of your company and the type of facts to be registered, further documents must be submitted (in some cases also to be certified by the notary) You can find out which documents you need to submit in each individual case from the notary and the Chamber of Industry and Commerce.

Kosten	Fixed fees are charged for entries in the commercial register in accordance with the Commercial Register Fees Ordinance.

Verfahrensablauf	To submit an application, please contact a notary. • The notary will advise you on how to formulate the application. • The application is made exclusively by electronic means and a publicly notarized document is created for this purpose. • The declaration is provided with a qualified electronic signature (within the meaning of Section 39a of the Notarization Act (BeurkG) and sent to the electronic court mailbox of the registry court. • The registry court enters the entry in the court's internal database and also publishes the entry on the Internet (www.handelsregisterbekanntmachungen.de)
