Teaser	The intended sale of pyrotechnic articles of categories F1 and F2 must be notified to the competent authority at least 14 days before the start of the activity. If pyrotechnic articles are sold on an annual basis, a single notification is sufficient.
Volltext	The intended sale of pyrotechnic articles of categories F1 and F2 must be notified to the competent authority at least 14 days before the start of the activity. If pyrotechnic articles are sold on an annual basis, a single notification is sufficient. A new notification is required if changes have occurred since the initial notification (e.g. change of address, changes in the persons responsible) or if the sale is discontinued. For each sales facility, a sufficient number of responsible persons must be appointed to act as supervisors for the sale and/or storage. These persons must be appointed by internal organization.

Hinweise	Small quantities of pyrotechnic articles of categories F1 and F2 may be stored without a permit. If you wish to store quantities in excess of this, you require a permit in accordance with § 17 of the Explosives Act. If you do not submit the notification required under § 14 of the Explosives Act, or do not submit it correctly, completely or on time, you may be liable to a fine as an administrative offense.
