| Volltext                         | A farrier, officially called a farrier in Germany, is a<br>specialist in the care (trimming) and shoeing of animal<br>hooves with horseshoes or other materials. He<br>traditionally makes the horseshoes and horseshoe<br>nails himself in the forging process or adapts the<br>horseshoes to the shape of the hoof. The work also<br>includes the treatment of injured and diseased hooves.<br>The law provides special protection for hoof and claw<br>trimming. Hoof and claw trimming may only be carried<br>out by persons who are certified and state-approved<br>farriers.<br>Training to become a farrier consists of the following<br>stages:<br>• A four-week introductory course at a state-approved<br>farriery school before taking up employment |

|                          | <ul> <li>Identity document</li> <li>Proof of completed vocational training</li> <li>Proof of two years of full-time employment subject to social insurance contributions (e.g. employment contract of at least 20 hours/week) with a farrier who has been practicing the farriery trade for at least three years following state recognition as a farrier</li> <li>Proof of successfully passing the examination after attending the required training courses</li> <li>Proof of the reliability required for practicing the profession (extended certificate of good conduct)</li> </ul> |
|                          | For persons with examination certificates obtained outside Germany:   |
|                          | <ul> <li>Identity document</li> <li>equivalent examination certificate,</li> <li>proof of the reliability required to exercise the profession (application for a certificate of good conduct or submission of a confirmation from the country in which the examination certificate was obtained, which shows that no violations of animal welfare have been committed)</li> </ul>   |

| Voraussetzungen                 | <ul> <li>State recognition as a farrier is granted if</li> <li>completed vocational training</li> <li>two years of full-time practical work, subject to social insurance contributions, with a farrier who has been operating a farriery business for at least three years following state recognition as a farrier</li> <li>attendance of the required training courses and successful completion of an examination and</li> <li>the reliability required to exercise the profession must be proven.</li> </ul> |
| Kosten                          | Is based on the respective administrative fee schedule<br>of the federal state or on the fee statutes of the<br>authorities responsible under federal state law.<br>Costs are charged according to time spent.   |
| Verfahrensablauf                | <ul> <li>You submit the application including the required<br/>evidence to the responsible body</li> <li>They will check whether all requirements for state<br/>recognition have been met</li> <li>If the examination is positive, you will be granted<br/>state recognition as a farrier</li> </ul>   |
| Bearbeitungsdauer               | Once the application for recognition has been submitted, the competent body will decide on this in a timely manner.  |

| Hinweise                        | Anyone who intentionally or negligently carries out<br>farriery and hoof trimming as a farrier or specialist<br>training at farriery schools as a farriery instructor<br>without the required state recognition is acting in<br>breach of the regulations (Section 9 HufBeschlG).  |
