<b>Volltext</b>	<p>On the basis of the certification made in the birth register, you can apply for a birth certificate for a home birth.</p> <p>If you have given birth to your child at home, you must notify the registry office of the birth verbally.</p> <p>The following persons are obliged to report the birth within the first week:</p> <ul style="list-style-type: none"> <li>• the child's father, if he has custody of the child</li> <li>• the midwife who was present at the birth</li> <li>• the doctor who was present at the birth</li> <li>• any other person who was present at the birth or is aware of the birth from their own knowledge</li> <li>• the mother, as soon as she is able to give notice.</li> </ul>

<b>Erforderliche Unterlagen</b>	<ul style="list-style-type: none"> <li>• for parents who are married to each other birth certificates Marriage certificate or a certified copy of the marriage register</li> <li>• for parents who are not married to each other Birth certificate of the mother if paternity has already been recognized: Declarations of acknowledgment of paternity Birth certificate of the father declarations of custody, if applicable</li> <li>• Parents' identity card, passport or a recognized passport replacement document</li> <li>• a certificate of birth issued by a doctor, midwife or maternity nurse, if they were present at the birth.</li> </ul> <p>A marriage certificate must also be submitted if the marriage has been dissolved.</p>
<b>Voraussetzungen</b>	
<b>Kosten</b>	Fees may apply. Please contact the responsible office.
<b>Verfahrensablauf</b>	<p>You will receive the birth certificate on application.</p> <p>You must appear in person at the registry office in the place of birth.</p> <p>After the birth has been certified, you will receive a birth certificate from the registrar if the child's name has already been determined, otherwise a birth certificate.</p> <p>Birth certificates are issued free of charge once for religious purposes and for pregnancy and maternity assistance. For other purposes, certificates are issued free of charge if this is provided for by federal or state law.</p> <p>The registry office will inform the registration office of the birth of your child. If you require a birth certificate or a certified copy from the register of births, you must apply for this at the registry office for a fee.</p>
