| Volltext | <p>The guardianship is generally to be carried out **free of charge**. If the guardianship is exceptionally carried out professionally (by a professional guardian), there is a right to remuneration. A guardian working on an honorary basis only receives remuneration in exceptional cases if the guardianship court approves such remuneration due to the scope and difficulty of the guardianship tasks in the case of wealthy guardians.</p> <p>The remuneration of professional guardians is based on the provisions of the Guardianship and Caregiver Remuneration Act (VBVG) and therefore on the qualifications of the guardian.</p> |
