Verfahrensablauf	You must submit a written application for recognition as a tax consulting company. The competent chamber of tax advisors checks, on the basis of the articles of association or the statutes, whether proof of the responsible management of the company by tax

Bearbeitungsdauer	After receipt of the complete documents, the Chamber of Tax Consultants checks whether the legal requirements for recognition are met.

Hinweise	<p>Prior to entry in the commercial or partnership register, the competent chamber of tax advisors may already confirm that, with the exception of entry in the commercial or partnership register, all requirements for recognition have been met. A written decision shall be issued on the acceptance of the application for recognition. Rechtsbehelf	An action against the refusal of recognition as a tax consulting company is admissible before the Tax Court.
