Teaser	<p>Association of landowners for the joint management of their forest areas in a forest management association (FBG).</p> <p>Thuringia:</p> <p>You would like to establish a forest management association and manage your forest jointly?</p> <p>Then you have to apply for recognition at the highest forestry authority (Thuringian Ministry of Infrastructure and Agriculture).</p>
Volltext	<p>Forest management associations (FBG) are associations of landowners under private law. Their main purpose is to compensate for the disadvantages of small area size in the management and various structural deficiencies in the management of their forest areas.</p> <p>The content and legal aspects of the statutes of the forest management association submitted by you with the application for recognition are examined.</p> <p>If no objections are raised against the content of its statutes, the approval of the statutes is granted by the supreme forestry authority.</p> <p>At the same time, the forest management association is granted the legal form of an economic association upon application and a certificate of recognition and award is issued.</p>

- Gresolution on the establishment of the forestry cooperative
- certified signatures of the board members by the responsible forestry office

- statutes adopted by the general meeting

Beneficiaries in \*\*Thuringia\*\* are forest owners (small forest owners, cities and municipalities, forest cooperatives).

A forest management association is recognized by the authority responsible under state law (in Thuringia):

	<p>Thuringian Ministry of Infrastructure and Agriculture) upon application if it meets the following requirements:</p> <ol style="list-style-type: none"> <li>1\.\. it must be a legal entity under private law;</li> <li>2\.\. it must, by virtue of its size, location and context, allow for a significant improvement in management</li> <li>3\.\. in the case of the legal form as an economic association (in Thuringia exclusively) it must have at least 7 members;</li> <li>4\.\. it must give itself a statute, which covers minimum contents.</li> </ol> <p>-In Thuringia, the minimum area must be 50 hectares.</p>
Kosten	<p>1,00 - 51,00 Euro</p> <p>on request exemption from fees due to special public interest</p> <p>Administrative costs</p> <p>50 Euro administrative costs, according to No. 4.3.1.11 of the Administrative Costs List (Annex to § 1 Para. 1) of the Thuringian Administrative Cost Regulations for the Business Division of the Thuringian Ministry of Infrastructure and Agriculture.</p>
