Verfahrensablauf

The application procedure consists of two stages:

- Stage 1 is the registration of the funding project.
- Stage 2 comprises the application for the funding project. An exception to this is the funding of dialog displays; a prior notification of need in accordance with 7.2.1 of the guidelines is not required.

The detailed procedure is as follows:

- Registration of the project by the municipality by March 31 of the year preceding the start of the project
- Examination of the applications received and preparation of a funding program framework
- The local authority is informed (in July) that the project has been included in the funding program framework and is requested to submit an application, including draft planning, by 31.10.
- Application for the project by the municipality by 31.10. of the year preceding the start of the project. For dialog displays between 01.09. and 31.10. of the year preceding the start of the project.
- Preparation of the funding program after examination of the applications received and in accordance with the available state budget funds
- Informing the applicant about program acceptance, requesting missing documents if necessary
- Examination of the application

Once the application has been reviewed, the funds are transferred to the account of the grant recipient specified in the application.</p> <p>Income from repayments by the grant recipient (e.g. overpayment after final settlement, reclaims and interest claims by the authority) are also transferred by the grant recipient to the authority.</p>
Rechtsbehelf	<p>The approval notice contains a right of appeal. An appeal against the authority's decision can be lodged within one month.</p>
