| Volltext                         | You require a permit for the commercial transportation of persons by rental car. You can submit an application to this effect to the traffic authority responsible for you in the respective independent city or district.  The so-called occasional traffic with motor vehicles includes, among other things, the traffic with cabs, excursion trips and vacation destination trips, or the traffic with rental cars and rental buses. In order to obtain a license, the entrepreneur must meet the following requirements: the financial capacity of the business and the professional suitability of the entrepreneur must be guaranteed, and the applicant or the person entrusted with the management of the business must be reliable.
