Teaser	If you have entered into a land lease agreement or wish to notify a change to it, this must be notified to the competent authority within one month by the lessor.
Volltext	Each land lease agreement concluded or its amendment shall be notified to the competent authority within one month by the lessor. Notification of land lease agreements may also be made by the lessee, who is entitled to do so. The notification shall be confirmed by the authority if the contract is not objectionable.
Erforderliche Unterlagen	Concluded land lease agreement or amendments, with indication of the sender.
Voraussetzungen	Concluded contract according to regulations of § 585 BGB, hereafter stating: lessor, lessee, land parcel designation, lease term, lease price.
Kosten	none
Verfahrensablauf	The concluded land lease contract between the lessor and the lessee shall be submitted to the competent authority within one month by the lessor or the lessee. The competent authority checks the contract for completeness and with regard to the assessment (objection) according to the LPachtVG.

Bearbeitungsdauer	Within the 1 month period, can be extended to 2 months
Frist	The notification of the conclusion of the contract and the amendment to the contract shall be made within one month of their agreement.
