Teaser	Exceptions to the truck driving ban during the vacation travel season (July and August) are possible upon request.
Volltext	For urgent reasons, it may sometimes be necessary to deviate from prescribed driving bans in the Road Traffic Regulations. For such justified individual cases, an exception can be granted after application.
Erforderliche Unterlagen	Evidence of the need for a special permit for the specific situation. The justification must state why it appears unreasonable to carry out the transport on the subordinate road network in order to circumvent the prohibited routes. If applicable, further documents required by the competent authority.
Voraussetzungen	Anyone with a justified request is entitled to apply. Exemptions shall be granted only in cases of urgent need, with due regard to traffic safety and order in particular. The granting of exemptions for commercial purposes shall be limited to urgent cases. Detours are to be accepted as a matter of principle, since economic or competitive reasons alone do not justify the granting of exceptions.
Kosten	According to the Fee Regulations for Road Traffic Measures (GebOSt), there is a general fee range of

Verfahrensablauf	Application incl. justification to the responsible authority Application review with possible involvement of other agencies Application processing by the competent authority Granting or rejection of the exception
Bearbeitungsdauer	Depending on the individual case and involvement of other agencies.
Frist	As a rule, no deadlines apply, but an application should be submitted as early as possible and not at short notice. Certain processing times should be granted to the authority.

Hinweise	As transport can also be carried out outside the prohibited routes during the vacation travel period (July and August), a particularly strict standard must be applied when considering the granting of exemptions. The granting of exemptions for commercial purposes must be limited to urgent cases. Detours must be accepted as a matter of principle, since economic or competitive reasons alone do not justify the granting of an exception.
Rechtsbehelf	The decision (administrative act) on an application may be appealed by means of an objection/complaint.
