Teaser	Do you discharge wastewater into surface water or groundwater? Then you must pay a levy to the Free State of Thuringia. You should submit the declarations (forms) required for the assessment of the levy to the responsible office.
Volltext	For the discharge of wastewater (wastewater or polluted rainwater) into surface waters or groundwater is subject to a wastewater levy in Germany under federal and supplementary state law. The wastewater levy is collected by the individual federal states.r.
Erforderliche Unterlagen	<p>The wastewater levy is determined on the basis of the discharge permit under water law, in which the monitoring values and the annual wastewater volume are regularly listed; this is generally available to the determining authority.</p> <p>Depending on the discharge situation, the following declarations or applications must also be submitted:</p> <ul style="list-style-type: none"> • Declaration in accordance with § 6 Para. 1 Sentence 1 AbwAG (declaration of the monitoring values and the expected annual pollutant water quantity, insofar as this information has not been specified in a permit under water law) • Application for consideration of prior pollution (of the body of water from which the water was taken directly) in accordance with § 4 Para. 3 AbwAG

Voraussetzungen	Anyone who discharges wastewater directly into a body of water is liable to pay the levy.
Kosten	Enforcement of the wastewater levy is free of charge.

Rechtsbehelf	An objection to the wastewater levy notice can be lodged with the assessment authority within one month of notification. The objection has no suspensive effect, i.e. the wastewater levy must be paid on time in any case.
Kurztext	A wastewater levy is charged in Germany for the discharge of wastewater (wastewater or polluted rainwater) into surface water or groundwater.

Zuständige Stelle	In Thuringia, the Thuringian State Office for the Environment, Mining and Nature Conservation (TLUBN), Ref. 51 "Wastewater, Wastewater Levy", is responsible.
Formulare	<p>The ABWAG-online program is available free of charge on the Internet for declarations and applications.
