Teaser	Under certain conditions, you can obtain an extension of your temporary residence permit. You must apply for this.
Volltext	<p>It is not possible to extend your residence permit beyond the initial six-month period as long as you have not legally resided in Germany for at least 18 months when the residence permit is first issued.</p> <p>If you have legally resided in Germany for at least 18 months, it is possible to extend the residence permit, which is initially limited to six months. The same requirements must be met as for the granting of a residence permit.</p> <p>An extension of the residence permit is only permitted if you are seeking a temporary residence permit. If you are seeking permanent residence or an unforeseeable stay in Germany, an extension of the residence permit cannot be granted.</p> <p>You must make sure that you apply for an extension or another residence permit before your residence permit expires. If the application is submitted in good time, i.e. before the expiry of the time limit, your continued residence is deemed to be permitted until the decision of the immigration authority with all subsequent effects (e.g. entitlement to social assistance). A late application (after the end of the period specified in the residence permit) can result in considerable legal disadvantages. Your continued stay would then be unauthorized. You are then obliged to leave the country.</p>

Verfahrensablauf	<p>As a rule, you must apply for the extension of your residence permit in person at your local immigration office.</p> <p>Arrange an appointment with your local immigration office. You can also find out about the application process and which documents you need to submit and in what form on the website of the relevant immigration office.</p> <p>If you have submitted an application for an extension within the deadline (before your residence permit expires), your current residence is deemed to be permitted until the foreigners authority makes a decision.</p> <p>If your application is approved, the Foreigners' Registration Office will commission the Federal Printing Office to produce the electronic residence permit (eAT) in the form of a check card with a new validity date.</p> <p>For information on the duration of the procedure until the residence permit is issued, please contact the relevant immigration authority.</p>
Bearbeitungsdauer	<p>As a rule, you will be informed of the duration of the procedure (approx. 6 to 8 weeks) by the responsible immigration authority when you apply for an extension. Note: The residence permit is issued as an electronic residence permit.</p>
Frist	<p>You must apply to extend your residence permit in good time before it expires. Apply for an extension of</p>

Hinweise	<p>If you intend to stay in Germany permanently, the extension of the residence permit for temporary residence is not an option.</p>
Rechtsbehelf	<p>The decision of the immigration authority can be appealed to the court named in the decision.</p>
