Volltext	<p>You will only receive information from the civil register about a large number of persons who are not named (group information) if this is in the public interest.</p> <p>You can freely compile the groups of persons with selected data. The following are available to you for this purpose:</p> <ul style="list-style-type: none"> • Date of birth, • gender • current nationality, • current addresses, • date of moving in and out, and • Marital status with the indication whether single, married, divorced, widowed, living in a civil partnership, civil partnership terminated or civil partner deceased. <p>In addition to the membership of the group you have compiled, you may be informed of your first name and surname, doctoral degree, age, gender, nationality, current addresses and legal representatives with first name and surname as well as address.</p>

Voraussetzungen	The information must be in the national public interest. This is understood to mean the interest of the general public, which must be distinguished from the interest of individual persons or groups.
