In addition, you will receive information about former names, date and place of birth and, if the person was |
|                                  | born abroad, also the state, marital status, limited to whether or not the person is married or in a civil partnership, current citizenship, former addresses, move-in and move-out dates, surname and first names and address of the legal representative, surname and first names and address of the spouse or civil partner, date and place of death and, if the person died abroad, also the state.
