Teaser	You can obtain a residence permit to work as a freelancer if you meet certain requirements.
Volltext	<p>You can obtain a residence permit for the pursuit of a freelance activity if you wish to pursue such an activity in Germany. Freelance activities include scientific, artistic, writing, teaching, educational or other self-employed professional activities as defined in Section 18 (1) of the Income Tax Act (e.g. self-employed doctors, notaries, tax consultants).</p> <p>If required, you must submit a professional license. The professional permit is a state professional license with which persons are allowed to work in a certain profession in Germany (e.g. medical professions, legal profession). If you do not yet have a professional permit, it is sufficient if you prove that it has been promised to be granted.</p>

<b>Voraussetzungen</b>	<p>\- You are in possession of a recognized and valid passport or passport replacement and - if required for entry into Germany - an appropriate visa.</p> <p>\- There is no interest in deportation against you.</p> <p>\- Your stay does not endanger or impair the interests of the Federal Republic of Germany.</p> <p>\- You want to exercise a self-employed, freelance activity in Germany.</p> <p>\- You have the required permit to practice as a freelancer or you have been assured by the competent authority that the permit will be granted.</p> <p>\- If you have reached the age of 45, you must also be able to prove that you have adequate retirement provisions.</p> <p>\- You can secure your livelihood and health insurance coverage from your own resources without claiming public benefits.</p>
<b>Kosten</b>	<p>Issuance of residence permit: EUR 100.00</p> <p>Under certain circumstances, a fee reduction or fee waiver may be considered.</p> <p>Notes:</p> <p>\- Additional fees may apply for the issuance of the residence permit in the form of the electronic residence title, which can also be used as electronic proof of identity.</p> <p>\- The time and form of charging as well as payment vary depending on the authority.</p>
<b>Verfahrensablauf</b>	<p>The procedure is as follows:</p> <p>\- Depending on the foreigners authority and your request, it may be possible to apply via the Internet. Find out whether your foreigners authority offers electronic application for the residence permit.</p> <p>\- If the application is only possible in person, make an appointment with the Aliens' Registration Office. 	<p>received and your supporting documents will be checked (bring them with you to the appointment). For the production of an electronic residence permit (eAT card) your fingerprints will be taken.</p> <p>\- In the case of an electronic application, the Aliens' Registration Office will contact you after receiving your online application to arrange an appointment at the Aliens' Registration Office, if necessary. During the appointment, your supporting documents will be checked (bring them with you to the appointment) and your fingerprints will be taken for the production of the electronic residence permit (eAT- card).</p> <p>\- If your application is approved, the Aliens' Registration Office will arrange for the eAT card to be produced.</p> <p>\- After about six to eight weeks, you can collect the eAT card from the Aliens' Registration Office.</p> <p>\- The eAT card must always be collected in person.</p>

Frist	<p>\- The residence permit should be applied for at least eight weeks before your visa or current residence permit expires. \- The residence permit is issued for a limited period of time. \- Action period: 1 month</p>

Kurztext	<p>\- Residence Permit for the Purpose of Gainful Employment, Issuance for Freelancers</p> <p>\- Foreigners who wish to work as freelancers in Germany can obtain a residence permit if they meet certain requirements.</p>

	<p>\- If a special professional permit is required to exercise the freelance profession, e.g. for doctors, pharmacists, dentists, veterinarians, lawyers, tax consultants (e.g. license, license to practice), this must be available or at least the granting must be assured.</p> <p>\- Depending on the foreigners authority and the request, the application can be made via the Internet or in person.</p> <p>\- A fee is charged for the issuance of the residence permit. The time as well as the form of payment varies depending on the authority.</p> <p>\- Responsible: the foreigners authority responsible for the applicant's place of residence.</p>
